Waiver of Liability

In registering and permitting my child _____ to attend YMCA Day Camp Program, I, the undersigned parent, guardian or other duly authorized party, hereby agree as follows:

1. **Waiver:** I permit my child to participate in the full range of YMCA Camp activities, including offsite trips. I authorize the YMCA Staff, in the event of accident, injury, or illness affecting the above named camper, to authorize on my behalf all medical and other procedures, including ambulance transfer, admission to hospital and all other necessary treatment, as deemed essential for the care and well-being of the said camper. Such action is to be taken only when immediate contact with a parent or emergency contact cannot be made.

By participating in YMCA programs and/or by using any YMCA fitness equipment or facilities, I agree that I, and/or the minor identified above, are participating voluntarily and do so at my/our/their own risk. I agree to fully release the YMCA and its officers, directors, agents, staff, instructors and volunteers from all claims or lawsuits for an injuries, death, property damage or theft, losses, or any other liability of any kind including any claim for damages resulting from and arising out of either the negligence of the directors, officers, agents staff and volunteers of the YMCA or the negligence of any other person or guest using the facilities that may arise directly or indirectly out of my/our/their participation in YMCA programs and/or use of any YMCA equipment of facilities.

2. **Loss/Theft:** That the YMCA of Eastern Ontario is not responsible for any loss or theft of participants' belongings or money. Parents/guardians will be responsible for reimbursement of any theft, willful destruction to property incurred as a result of their child's actions. To help minimize risk, we ask that no personal items come to camp.

3. **Program Removal:** The YMCA of Eastern Ontario has a no-nit policy. Behavior that puts the participant, other campers, staff, or other members at physical or emotional risk may result in immediate dismissal from the program. Possession of alcohol, weapons, tobacco products and illegal or harmful substances will result in immediate dismissal from program. Any expenses incurred because of program dismissal will be the responsibility of the parent / guardian. Parents / guardians or a suitable designate must be available to pick up participants promptly should the participant be dismissed from the program. No refund will be given to campers leaving camp prior to the end of the session or summer due to disciplinary action.

4. **Refunds and Cancellations:** I understand there will be a \$20 fee for any cancellations, 3 business days prior to the scheduled camp day/week; cancellations after this time will be granted for extreme emergencies only and at the discretion of the Supervisor. Refunds will not be issued if a participant is removed from the camp program at the choice or request of the participant or the participant's parent/guardian or due to behavioural issues once the camp has started. The YMCA of Eastern Ontario reserves the right to cancel registration if the camper's medical information is not completed and if the authorization is not signed by the parent/guardian and returned to the YMCA prior to the start of the camp session.
